Proviso 117.74 – Fines and Fees

Authority

Lander University derives its authority to assess various fines and fees in accordance with the South Carolina Code of Laws, Title 59, Chapters 101, 112 and 135 as well as provisos 117.7 and 117.8 of the FY 2017-18 Appropriations Act. Title 34, Chapter 11 of the South Carolina Code of Laws authorizes a fine for returned checks.

Expenditure Purposes

Categorized as follows

Tuition – Revenue used to support the instruction, research and public service mission of the University. Tuition is collected for the purpose supporting the program needs of the academic units which in turn provide regular course instruction to the students. These unrestricted funds comprise the majority of revenue to the University's operating General Fund. Figures include Summer II, Fall, Spring and Summer I semesters. <u>E&G</u> (Education & General) Course Amount represents that portion of the tuition directly related to providing course instruction to the students. <u>Board Mandated Fees</u> represents that portion of tuition dedicated to covering expenses related to bond debt service, student activities, renovation reserve, Technology, athletics activity as well as the Health and Wellness Centers. Tuition presented in this report is shown in the same manner as the university's audited financial statements (i.e., net of scholarship allowances).

Academic – Revenue derived from various fees assessed by the academic departments that cover expenses unique to instruction associated with that discipline including, but not limited to, supplies and materials, travel and insurance.

Applications, Transcripts and other fines & fees – Revenues used to cover direct and indirect expenses associated with administrative processing of records and information. This category Includes application fees, transcript fees, deferment fees and library fees and fines.

Housing – Revenue used to cover the various costs associated with housing including, but not limited to, salaries and fringe benefits, utilities, furniture, maintenance and repairs.

Meal Plans – Outsourced for the campus. Revenue is used to compensate the contractor for services rendered through contractual arrangements.

Parking – Revenues used to cover the cost of parking services.

Technology – Revenues used to cover the cost of residence hall wireless network, IT security, technical support, phone and salaries and fringe benefits for some IT staff. A portion of the revenue is directed to modernizing, streamlining, and enhancing the University's computer systems.

Safety & Security – Revenues used to enhance the safety and security of on and off campus students. Increased cyber security measures, parking lot cameras, purchase of university policy body cameras etc. Athletic – Revenues used to offset Athletic operations in order to free university funding to enhance the academic experience. Provide students with free admission to all Athletic ticketed events.
Student Activities – Revenues used to provide students with admission to the weight room and to bring quality entertainment on campus to engage students and encourage them to fully embrace campus life.

Returned Checks – Revenue used to offset the cost of collections associated with accounts receivables.

Transfer of Fines and Fees Revenue

No revenue derived from the University's various fines and fees were transferred to the General Fund of the State, nor to any other entity.

RETURN CHECK CHARGE - Charge for check returned by bank \$25

HOUSING APPLICATION FEE - A boarding student is required to pay a \$150 non-refundable application fee per academic year

SINGLE ROOM - A student who requests single occupancy in a double room will be charged an extra one half the semester fee for residence hall involved per semester. (Subject to availability).

TEXTBOOKS - Normally allow between \$500 - \$600 per semester. For your convenience, the Bookstore accepts Visa, MasterCard, Discover and American Express Credit Cards.

REFUND POLICY - No refunds or reduction of basic charges will be made due to a change in status (e.g. from full-time student to part-time student) after the last day to drop/add for the semester. No refunds will be made to part-time students for reduction of hours after the last day to drop/add for the semester. The date the student files written notice of withdrawal with the Registrar's Office is the date in determining refunds. Refunds will be determined according to the policy in the current catalog and will be processed within 30 days of date of withdrawal.

OTHER FEES AND EXPENSES*

COURSE OVERLOAD FEE: Students enrolled in 19 hours or more will pay an additional \$150 per credit hour.

EMERGENCY MANAGEMENT NON-RESIDENT FEE: Non-resident students enrolled in Emergency Management Masters Degree Program will be assessed a \$150 fee each semester.

RE-REGISTRATION FEE: Students whose classes were canceled and want to re-register will be charged \$100.

FRESHMAN ORIENTATION FEE: Students attending orientation will be required to pay a \$120 fee that will be included as part of fall bills.

APPLIED MUSIC FEE: (10 - 12 hours of private instruction)

Students majoring or minoring in music and taking Applied Music will be charged an additional \$200 per semester for one hour applied lessons (MUSK, MUSN, MUSV:150, 151, 250, 251, 350, 351, 450, 451) plus normal fees.

Students majoring or minoring in music and taking Applied Music will be charged an additional \$100 per semester for 30 minute applied lessons (MUSK, MUSN, MUSV: 152, 153, 154, 155, 252, 253, 254, 255, 352, 353, 354, 355, 452, 453, 454, 455) plus normal fees.

INTERNATIONAL STUDENTS: All students classified as international students will be required to participate in the Lander University International Student Insurance Program. No exceptions will be made to this policy. International students are required to purchase mandatory student medical insurance offered through an outside company.

Student Athlete - \$1,491 Student Non-Athlete - \$842

A one-time matriculation fee of \$300 will be assessed for new and transferring international students.

SENIOR CITIZENS: Senior citizens may register for classes only *after* regular registration times on a space available basis at no cost.

NURSING SPECIAL EXPENSES: Special expenses for nursing students are approximately \$500. For more detail, see the Nursing Student Handbook available at http://www.lander.edu/Academics/Colleges-Departments/Science-Mathematics/Nursing/Programs.aspx
